# MEMBERS BADGE DRAW ILLAWARRA YACHT CLUB TERMS & CONDITIONS

# Eligibility

- 1. The promoter is Oak Flats Bowling & Recreation Club, Kingston Street, Oak Flats NSW 2529.
- 2. To be eligible, entrants must be over 18's years or over and hold a financial membership of Oak Flats Bowling & Recreation Club and Illawarra Yacht Club.
- 3. Members cannot collect the winnings on behalf of another member. The winning member must produce their valid membership card and additional ID if required.
- 4. Winner must attend Illawarra Yacht Club where the promotion is called and will have 4 minutes to notify staff and produce their valid membership card.
- 5. Oak Flats Bowling & Recreation Club and Illawarra Yacht Club staff members and directors are ineligible to enter the draw.

## Entry

1. To enter, members must be financial members of Oak Flats Bowling & Recreation Club and Illawarra Yacht Club. To be eligible for the prize, member must present themselves to Club staff within 4 minutes of their name being called out during the draw time.

#### Draw

1. Regular badge draws will take place at:

- 2. Once the jackpot reaches \$10,000, the draws will take place at:
