TERMS & CONDITIONS

BOOKING CONFIRMATION & DEPOSIT

FINAL INVOICE & PAYMENT

A final invoice will be issued within 48 hours of receipt of confirmed final numbers. Full payment of the final invoice must be completed prior to the event date unless otherwise agreed in writing by management.

DAMAGE & LIABILITY

The client accepts responsibility for any loss, damage, or excessive cleaning caused by guests, contractors, or invitees attending the function. Any repair or replacement costs incurred as a result of damages to venue property, furnishings, equipment, or facilities may be charged to the client following the event.
